In this regard, he filed this Miscellaneous Petition, seeking to implead the proposed respondents herein, as respondents 2 and 3 in the main appeal.

Management has submitted that the first respondent Management has no serious objection in ordering this petition. He further added that the charge Memo has already been issued and disciplinary proceedings are going on as against the petitioner and therefore, prays for short accommodation.
