ORDER

2 After advancing arguments for some time, the learned counsel for the petitioner, on instructions, seeks the permission of this Court to withdraw this writ petition with a liberty to pursue his remedy in the pending suit in WOS.No.81/2016, on the file of the Wakf Tribunal [Court of Subordinate Judge, Krishnagiri] and also made an endorsement in the writ petition to that effect.

3 In the light of the endorsement made, the writ petition is dismissed as withdrawn. Liberty sought for by the petitioner, is granted. No costs. Consequently, the connected miscellaneous petitions are also dismissed.
