Mr.V.Dhananjayan, learned Special Government Pleader appearing for the respondents 1 and 2, on instructions, would submit that with regard to an untoward incident happened on 23.01.2017, a case in Crime No.74 of 2017 was registered and the son of the petitioner, namely Anand was arrayed as one of the accused based on the confession statement given by a co-accused and since he has not been apprehended, the detenu, who is his father, was asked to cooperate with the enquiry and he has not been arrested and he has been let off today at around 12.00

noon. The said submission of the learned Special Government Pleader, on instructions, is placed on record.

3. Hence, this Habeas Corpus Petition is closed. However, the petitioner is at liberty to workout his further remedy in accordance with law before the competent forum. No costs.
