K.Balu and another).

We are of the view that as per the Supreme Court judgment a number of TASMALC shops would be required to be shifted and, thus, the suggestion of the petitioner as made in the petition may be examined keeping in mind that new shops may be required to be created and the representation disposed of within four months from today.

The petition, accordingly, stands disposed of. No costs.

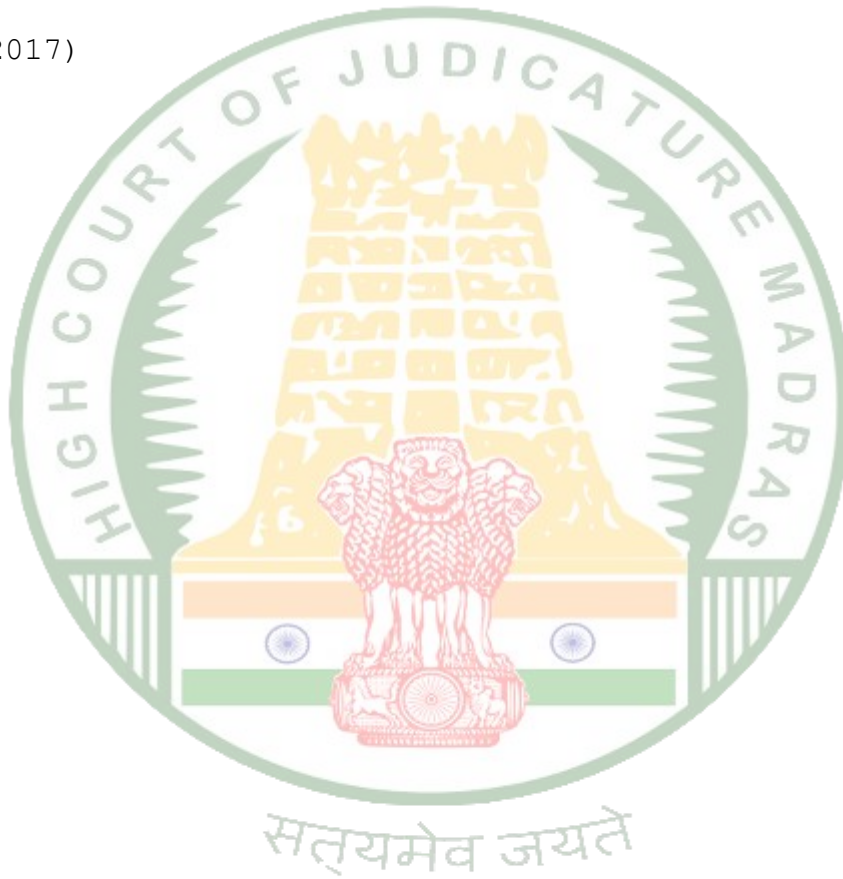
