Seeking to suspend the sentence imposed on the petitioner by the learned XIV Additional Judge for CBI Cases, Chennai-600 104 in C.C.No.27 of 2012 dated 21.08.2017 and enlarge the petitioner on bail pending disposal of the criminal appeal, the petitioner is before this Court with this petition.

2. Heard Mr.V.Krishnakumar, learned counsel for the petitioner and Mr.K.Srinivasan, learned Special Public Prosecutor for CBI Cases for the respondent.

Having regard to the facts and circumstances of the case, this miscellaneous petition is allowed and the substantive sentence of imprisonment alone is suspended and the petitioner is released on bail on condition that the petitioner shall execute a bond for a sum of Rs.1,00,000/- (Rupees One lakh only) with two sureties each for a like sum to the satisfaction of the learned XIV Additional Judge for CBI cases, Chennai-600 104. Further, the petitioner shall appear before the trial Court on the

first working day of every month at 10.30 a.m until further orders.
