Today when the matter is taken up for hearing, the learned Special Government Pleader has produced a copy of the letter of the Chief Engineer, Projects, Chennai dated 02.01.2017 stating that the amount of Rs.3,18,890/- is payable to the petitioner towards fee bill amount claimed in O.P.No.677 of

2002 and the petitioner has to pay the excess amount of Rs.83,721/- to the Government. Therefore, the balance amount of Rs.2,35,169/- is payable to the petitioner and they have also made necessary arrangements for payment of amount due to the petitioner.
