ORDER

4.Recording his statement, the respondents are directed to consider the petitioner's representations dated 05.11.2016, 03.12.2016, 09.03.2017 & 17.04.2017 and dispose of the same on merits and in accordance with law within a period of eight weeks from the date of receipt of a copy of this order.

5.With the above direction, the writ petition is disposed of. No costs.
