It is also reported that the petitioner has moved to a Civil Court in O.S.No.6 of 2017, pending before the learned Vacation Judge, Erode and despite the filing of the suit the respondents caused harassment to the petitioner.

4. In the said circumstances, all the respondents are directed to look into the complaint dated 16.05.2017 and pass appropriate orders in accordance with law within a period of four weeks from the date of the receipt of a copy of this Order.

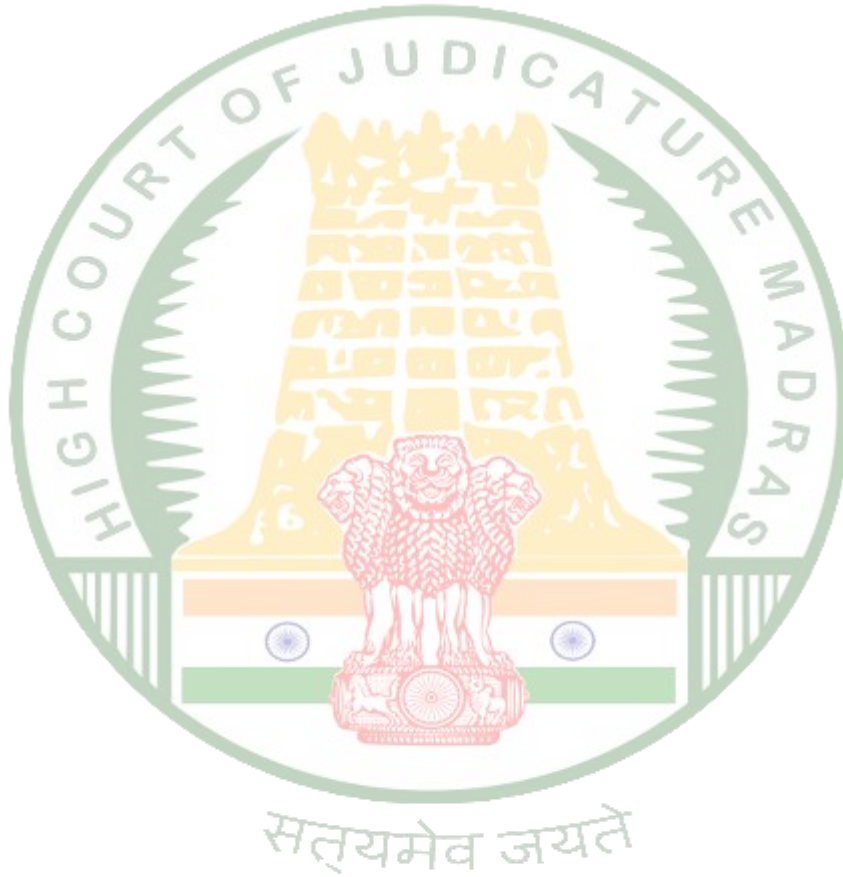
