PETITIONS under Article 226 of The Constitution of India praying for the issuance of Writs of Mandamus directing the respondents to consider and pass orders on the petitioners' individual representations dated 24.2.2017 as per the provisions of the Street Vendors (Protection of Livelihood Regulation) Act, 2014 made for granting permission/certificate of vending and till such time not to disturb with the running of the petitioners' bunk shops near (i) State Election Commission Office, Jai Nagar Corporation Park, Chennai-106; (ii) Karapakkam High Road, Rear Side of ELCOT IT Park, Backside Gate near Cognizant Company, Opposite to Tamil Nadu Forest Awareness Office, Chennai-97; and (iii) Poonamallee Bus Depot, Poonamallee, Chennai-56 respectively.

COMMON ORDER

(Order of the Court was made by K.KALYANASUNDARAM, J)

These writ petitions have been filed seeking a direction to the respondents to consider the petitioners' individual representations dated 24.2.2017 in accordance with the provisions of the Street Vendors (Protection of Livelihood Regulation) Act, 2014 and to grant permission/certificate of vending to the petitioners.

2. Learned counsel for the petitioners submits that though the petitioners approached the Vending Committee, no decision has been taken so far.

3. We direct the Vending Committee to take a decision on the respective representations of the petitioners dated 24.2.2017 in accordance with law and in particular, the provisions of the Street Vendors (Protection of Livelihood Regulation) Act, 2014 and the Rules framed thereunder, within a period of eight weeks from the date of communication of this order.

4. These writ petition are disposed of accordingly. No costs.
