COMMON ORDER

Mr.Venkatasamy Babu, learned counsel takes notice for the respondent. By consent of both sides, these writ petitions are taken up for disposal at the stage of admission itself.

2.In all these writ petitions, the writ petitioner seeks for a mandamus directing the respondent to dispose of his second appeals filed before the respondent under RTI Act within the time fixed by this Court.

law within a period of eight weeks from the date of receipt of a copy of this order, if not orders are passed so far. No costs.

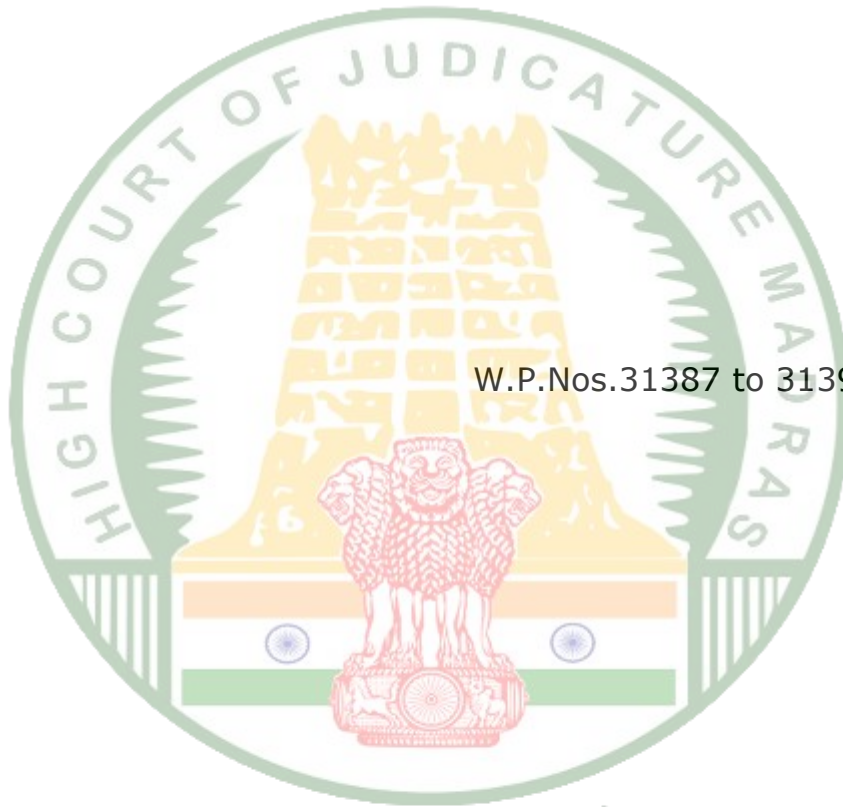
