2. Pending Criminal Original Petition, the defacto complainant/second respondent and the petitioners have amicably resolved the dispute between themselves.

3. In order to identify themselves, the petitioners 1 and 2 have submitted the photo copies of their respective Aadhar Cards viz., 1. K.Udayaprakash - 4001 9531 6283, 2.Malathy Udayaprakash - 8768 4428 9554 and the second respondent has also produced a copy of the PAN Card and after verification of the original cards, the same are recorded.

4. The second respondent as well as the petitioners are personally present before this Court and also have been identified by the first respondent police.
