JUDGMENT

Heard the learned counsel for the appellant/writ petitioner and the learned Special Government Pleader for the respondents.

2. We have perused the order of the learned single Judge.

For the proved misbehaviour and misconduct, the appellant was originally imposed with the punishment of stoppage of increment for seven years with cumulative effect. However, in the writ petition, the learned single Judge has thought it fit to affirm the order of the appellate authority, reducing the punishment of stoppage of increment from seven years to six years with cumulative effect. We do not find any reason to interfere with either the order of punishment or the order of the learned single Judge, having regard to the nature of allegations levelled against the appellant/writ petitioner. Accordingly, the writ appeal is dismissed. No costs.
