3. Thus, no further adjudication at this juncture is required in this contempt petition. Accordingly, the contempt petition stands closed.

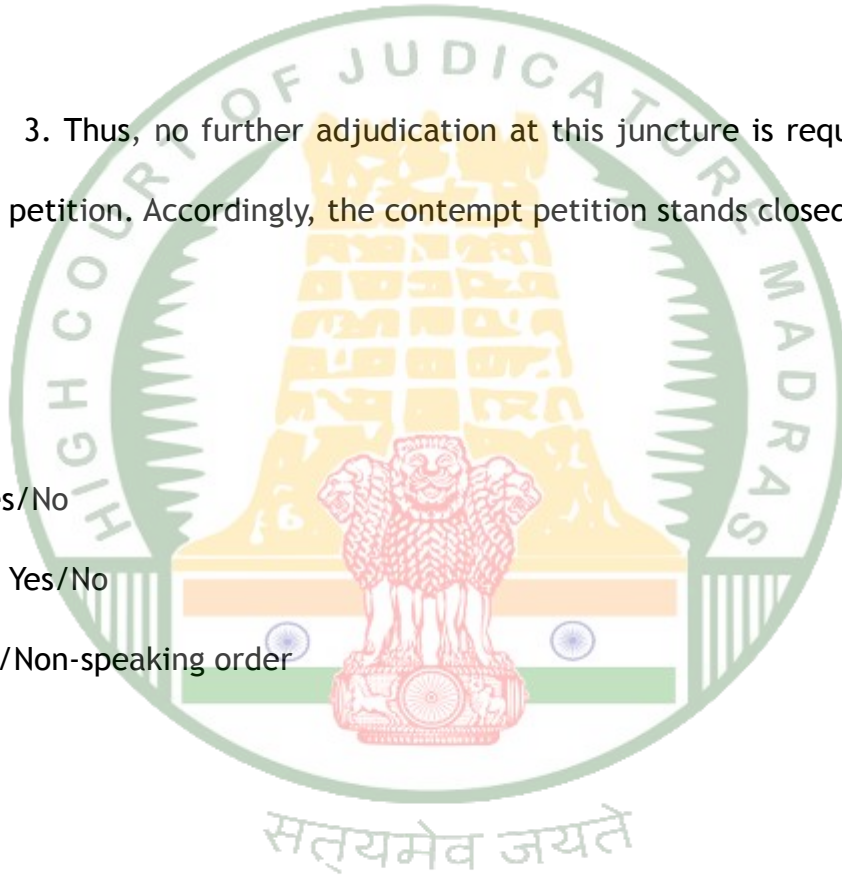
