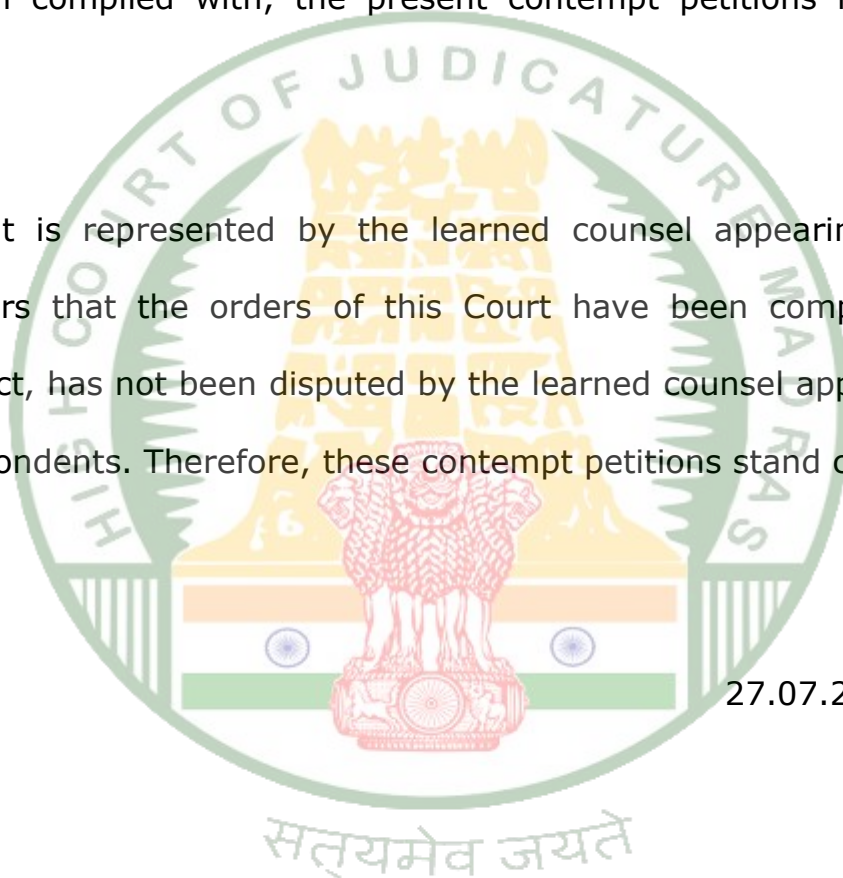
COMMON ORDER

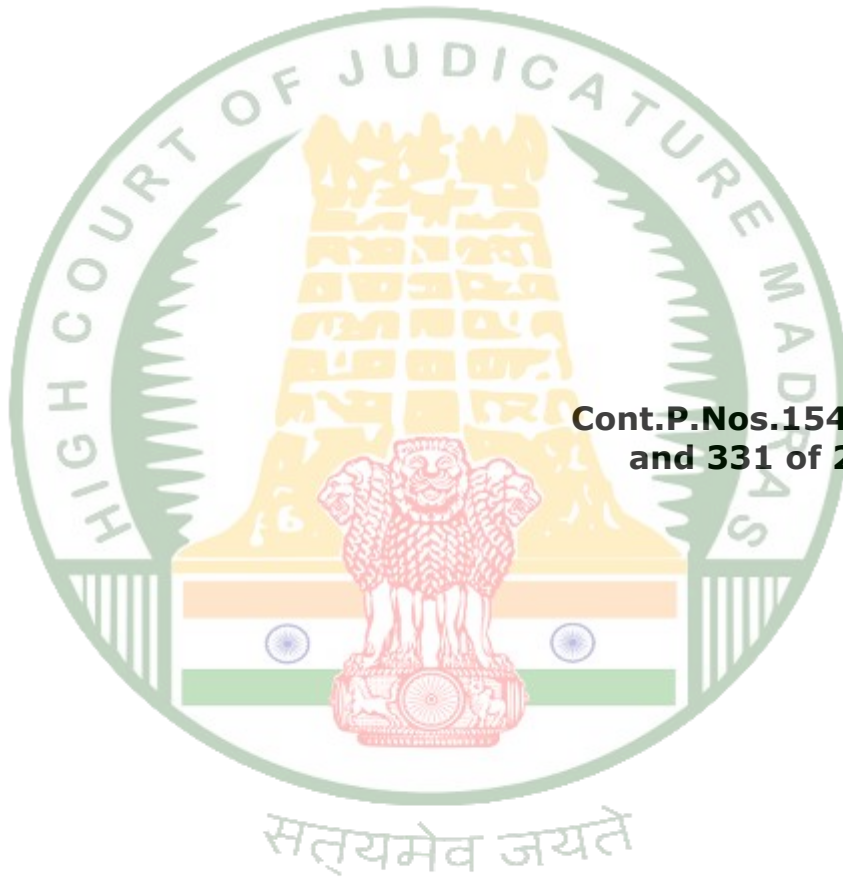
