5. The detainee/Ms.Manju Parkavi, is 23 years of age.
6. The petitioner, we are told, is, approximately, 30 years of age.
7. Since the detainee/Ms.Manju Parkavi is a major, according to us, she is free to take decisions concerning her own life.
8. Thus, the detainee/Ms.Manju Parkavi, is free to accompany the petitioner, if she so chooses.
9. This petition is, accordingly, closed.
