2. The original application filed by the petitioners have already been dismissed by the Tribunal. There is no question of granting interim direction at this point of time without setting aside the order passed by the Central Administrative Tribunal. We are therefore of the view that there is no merit in the miscellaneous petition.

3. In the up shot, we dismiss the miscellaneous petition.
