today, there is no representation for the petitioner. The Writ petition is dismissed for non prosecution. No costs.

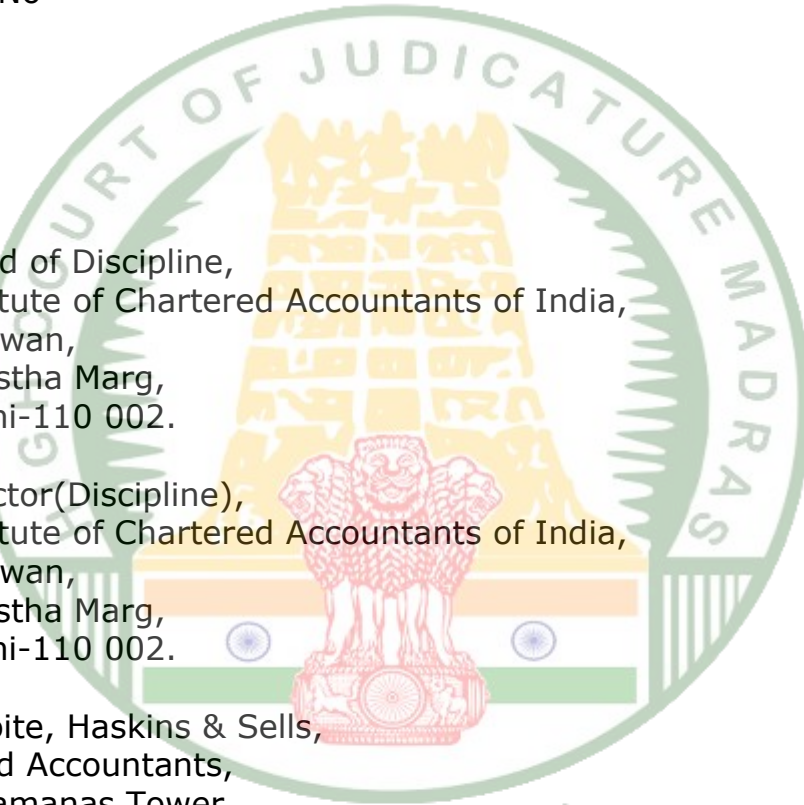

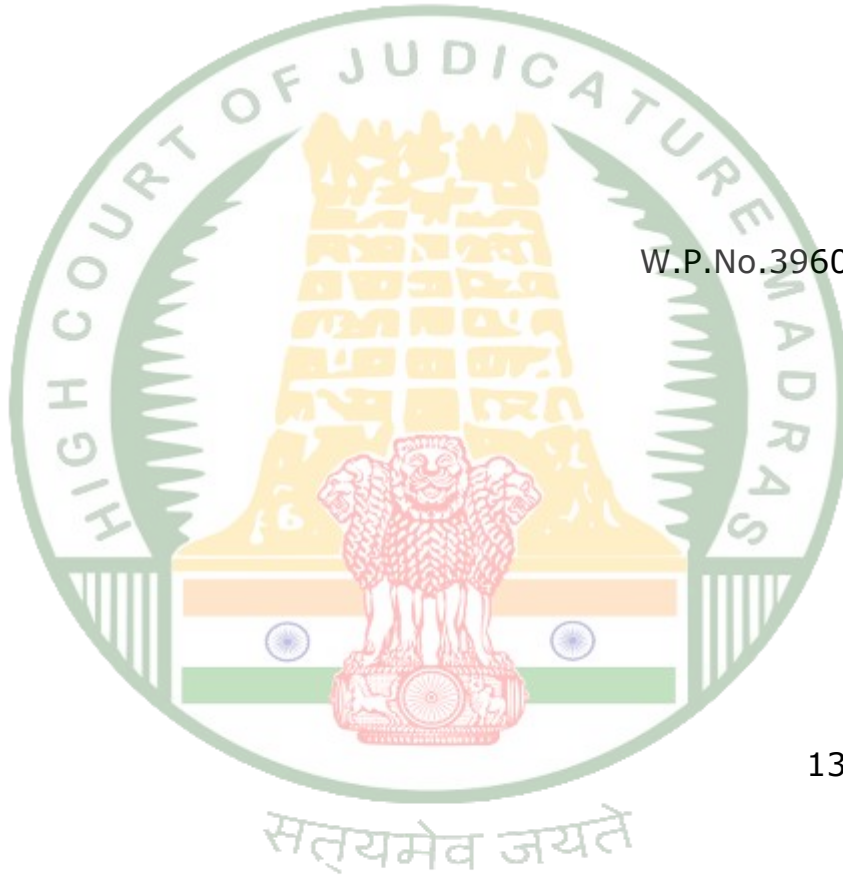
