2. We are further informed that the detainee/Ms.Sindhu is, presently, housed in Christ Faith Home (in short, "the Home").

3. Accordingly, the Superintendent of the Home, is directed to produce the detainee/Ms.Sindhu before the concerned Child Welfare Committee, at the earliest, though, not later than 22.12.2017.

4. The Child Welfare Committee will, thereafter, pass appropriate orders in the matter, keeping in mind the best interest of the child, i.e., the detainee/Ms.Sindhu

5. The captioned petition is, accordingly, closed.
