3. The petitioner seeks for a mandamus direct the

respondents 2 and 3 to measure the petitioner's property situated in Survey No.47/3, Korattur Village, Poonamallee Taluk, Thiruvallur District totally to an extent of 28 cents and erect milestone land issue patta in the name of the petitioner pursuant to the representation dated 05.10.2017 within a stipulated period of time.

4. The grievance of the petitioner before this Court, is that the said representation has not been considered so far. This Court, at this stage, is not expressing any view on the claim made by the petitioner, as it is for the 1st respondent to consider and decide the same. Thus, this writ petition is disposed of, only with a direction to the 1st respondent to consider the representation of the petitioner dated 05.10.2017 and pass orders on the same on merits and in accordance with law, after hearing the rival claimants, if any. Such exercise shall be done by the 1st respondent within a period of eight weeks from the date of receipt of a copy of this order. No costs.
