COMMON ORDER

(Order of the Court was made by the Hon'ble Chief Justice)

In view of the orders passed in W.P.No.15139 to 15145 of 2015 on 18.10.2016 (Saranya and others v. The District Collector, Thiruvallur District and others), the present petitions are also dismissed as withdrawn with liberty to avail of the appellate remedy under Section 10 of the Tamil Nadu Land Encroachment Act, 1905 along with application for interim relief. However, since in the present proceedings there were interim orders, the said interim orders shall continue to enure to the benefit of the petitioners till such time as the

appellate authority considers the interim applications, but uninfluenced by the continuation of this order.

These writ petitions stand disposed of accordingly. No costs. Consequently, M.P.Nos.1 of 2015 (21 petitions) and M.P.No.2 of 2015 (5 petitions) are closed.
