Subsequently, the said case was committed to the learned Additional Sessions Judge, Dharapuram and re-numbered as S.C.No.177 of 2011, which, after due trial, ended in conviction by judgment dated 12.02.2015.

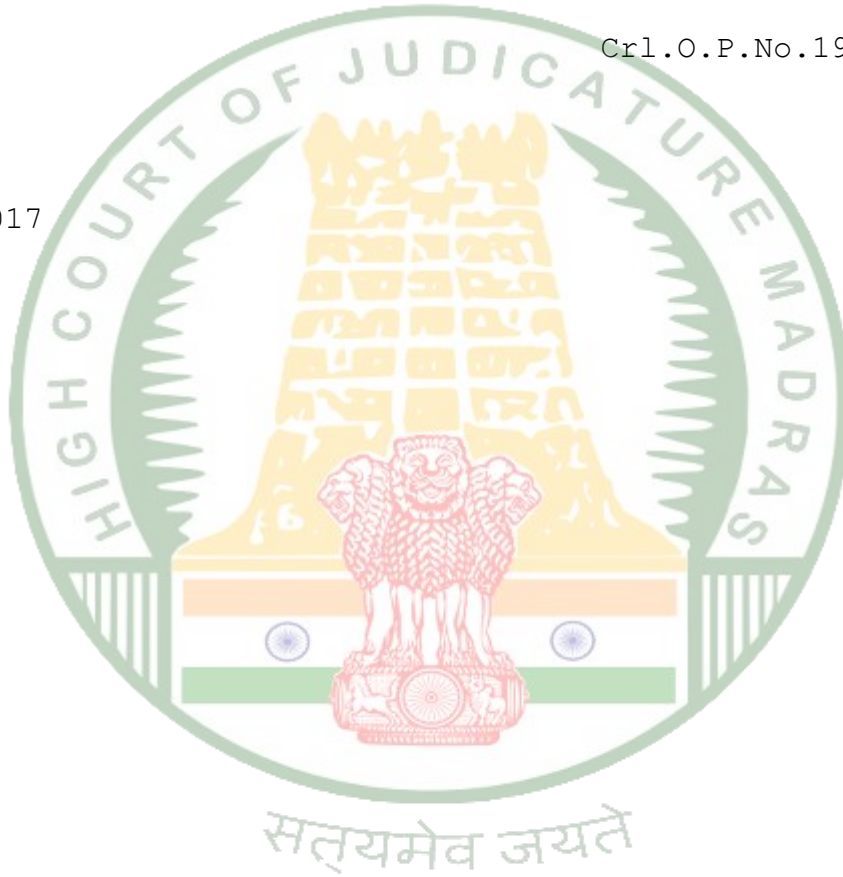
