Writ Petition filed under Article 226 of the Constitution of India to issue a Writ of certiorarified mandamus calling for the records of the orders dated 07.01.2014 passed by the 7th respondent in R.A.No.56 of 2013 in O.A.No.406 of 2013 together with the orders dated 05.11.2013 in M.A.No.639 of 2013 in O.A.No.406 of 2013 and in O.A.No.406 of 2013 in the file of the 7th respondent and quash the same as illegal, arbitrary, violation of Rule of Law as also in derogation of the fundamental rights guaranteed under Article 14, 16 and 21 of the Constitution of India and consequently direct 1st to 5th respondents to release all allowances from October 2011 to March 2013 along with pay allowances including annual increments from April 2013 to 30th April 2014 with interest at 12% thereof with consequential full pension to the petitioner.

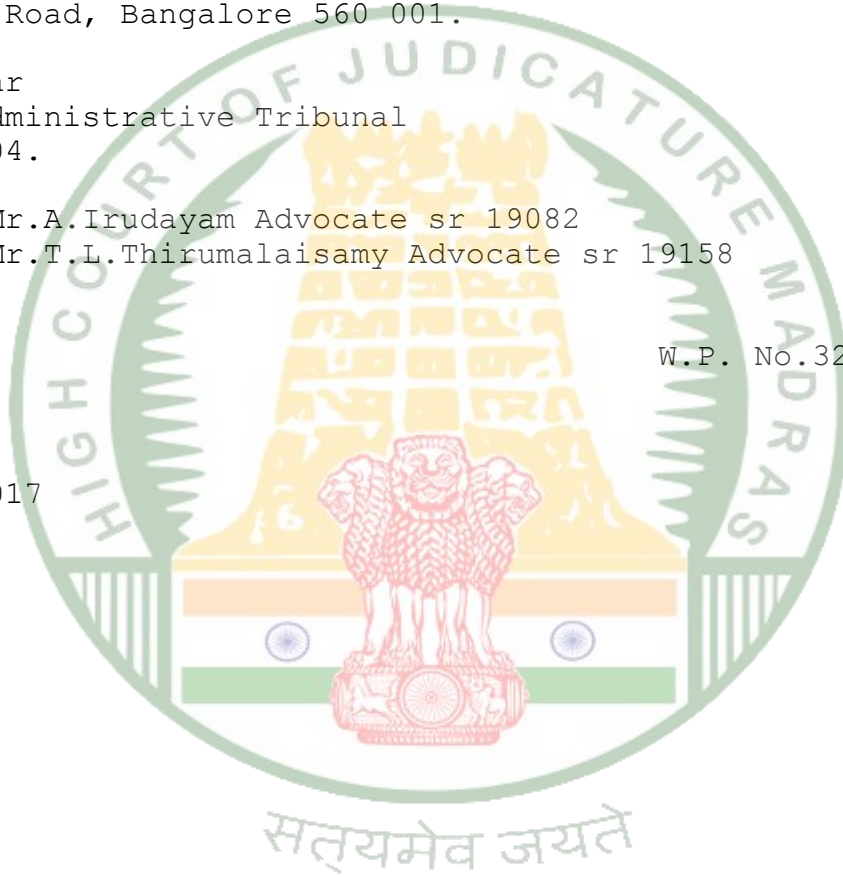
