1. The detenue/Mr.Mallikarjuna Rao has been produced in
Court.

1.1. The the petitioner is the wife of the
detenue/Mr.Mallikarjuna Rao.

2. It appears that there is a marital discord obtaining between the two. For the present, the detinue/Mr.Mallikarjuna Rao, does not wish to return to his wife, i.e., the petitioner.

2.1. The petitioner says that the detinue/Mr.Mallikarjuna Rao must, at least, reimburse the expenses incurred by her family on marriage and on dowry items.

2.2. In these proceedings, no such orders can be passed.

2.3. The petitioner will be at liberty to take recourse to appropriate proceedings, albeit, in accordance with law.

3. The petition is, accordingly, consigned to record.
