The learned counsel for the revision petitioners would submit that, challenging against the order passed in I.A.No.317 of 2016 in O.S.No.74 of 2016 dated 21.04.2016, the revision petitioners have preferred an appeal in C.M.A.No.14 of 2016 before the Subordinate Court, Ponneri. According to the learned counsel for the petitioners, there is no other legal impediment to dispose of the C.M.A.No.14 of 2016, now pending before the Subordinate Court, Ponneri. The said appeal is still pending for more than a year before the appellate Court. Therefore, the revision petitioners have filed the civil revision petition before this Court.
