3.Heard the learned counsel appearing for the petitioner as well as the learned Government Advocate appearing on behalf of the respondents 1 to 5.

4.The learned counsel for the petitioner would submit that there may be a direction to the respondents to consider the petitioner's representation dated 08.08.2016.

5.Considering the submission made by the learned counsel for the petitioner, this Court directs the second respondent to consider the petitioner's representation dated 08.08.2016 and pass appropriate orders on merits and in accordance with law as expeditiously as possible.
