Petition filed under Article 226 of the Constitution of India, praying to issue a WRIT OF HABEAS CORPUS, calling for the records of the first respondent culminating with the order of detention bearing reference Cr.M.P.No.12/Goonda/2016 dated 12.06.2016 passed by the first respondent herein under Section 3(1) of the Tamil Nadu Prevention of Dangerous Activities of Bootleggers, Drug Offenders, Forest Offenders, Goondas, Immoral Traffic Offenders, Sand Offenders, Slum Grabbers and Video Pirates Act, 1982 (Tamil Nadu Act 14 of 1982), quash the same and direct the respondents to produce the body of the person of the detenu KALAI @ TAMIL @ KALAITAMILVANAN S/o.Periyasami, aged about 24 years before this Hon'ble Court, now detained in the Central Prison, Coimbatore.

This Habeas Corpus Petition has been filed under Article 226 of the Constitution of India, praying to call for the records relating to the detention order passed in

Cr.M.P.No.12/Goonda/2016 dated 12.06.2016 by the Detaining Authority against the detenu by name, Kalai alias Tamil alias Kalaithamilvanan, aged 24 years, S/o.Periyasamy, residing at Ponmadurai, Pudupatti, Dindugul Taluk, Dindugul District, and quash the same.

2. Learned counsel appearing for the petitioner is not present.

3. It is seen from the records that the detention order in question has been passed on 12.06.2016 and the period of detention is one year.

4. Considering the above said factual circumstances that the period of detention has already been completed, the relief sought in the petition has become infructuous.
