This is a petition filed by the petitioner seeking suspension of sentence pending appeal.

2. I have heard the learned counsel for the petitioner.

3. Upon hearing the learned counsel for the petitioner, this Court is inclined to suspend the sentence. 4. Accordingly, the substantive sentence of imprisonment alone is suspended pending appeal and the petitioner is directed to be released on bail on his executing a bond for a sum of **Rs.1,00,000/- (Rupees one lakh only)** with two sureties each for a like sum to the satisfaction of the Special Court for the Cases under the Prevention of Corruption Act at Chennai-104 and on further condition that the petitioner shall

report before the Trial Court on every first working day of the month until further orders.
