Mr.P.Wilson, learned Senior Counsel appearing for the petitioner sought the permission of this court to withdraw the writ petition with liberty to file an appeal as against the impugned order passed by the 2nd respondent . The learned counsel on record has also made an endorsement to that effect.

3. In view of the same, the writ petition stands dismissed as withdrawn. It is open to the petitioner to challenge the impugned order dated 22.12.2016 before the 1st respondent in accordance with law. In the event of the 1st respondent entertaining the appeal to be filed by the petitioner, the petitioner is at liberty to raise all the issues before the 1st respondent. No costs. Consequently, connected miscellaneous petition is closed.
