Prayer in W.P.No.22871/17: Writ Petitions filed under Article 226 of the Constitution of India seeking a writ of mandamus to direct the respondents to revalue the question Nos.31,98,148 of Booklet Series "A" of the written examination for direct recruitment of PG Assistant (Tamil) in the year 2016-17 in the examination conducted on 02.07.2017 and to proceed with the selection for the post of PG Assistant in Tamil based on the revaluation with correct key answer and consequently to direct the respondents to award three marks to the petitioner (Roll No.17PG17012265) based on such revaluation and to select the petitioner to the post of PG Assistant in Tamil in MBC Community.

Prayer in W.P.No.22872/17: Writ Petitions filed under Article 226 of the Constitution of India seeking a writ of mandamus to direct the respondents to revalue the question Nos.45,52,101,144 of Booklet Series "C" of the written examination for direct recruitment of PG Assistant (Tamil) in the year 2016-17 in the examination conducted on 02.07.2017 and to proceed with the selection for the post of PG Assistant in Tamil based on the revaluation with correct key answer and consequently to direct the respondents to award three marks to the petitioner (Roll No.17PG14010715) based on such revaluation and to select the petitioner to the post of PG Assistant in Tamil in MBC Community.

3. Thus, in view of the above, the present writ petitions, seeking to revalue the same questions, which were already decided by this Court, cannot be sustained and accordingly, they are dismissed. No Costs. Consequently, connected miscellaneous petitions are closed.
