2. Learned Additional Public Prosecutor has submitted to the effect that the Detention Order in question has already been revoked by virtue of G.O.Rt.No.2905 dated 20.06.2017 and a copy of the same is submitted, wherein, it is clearly stated that the Detention Order in question has been revoked.

4. In fine, this petition is dismissed as infructuous.

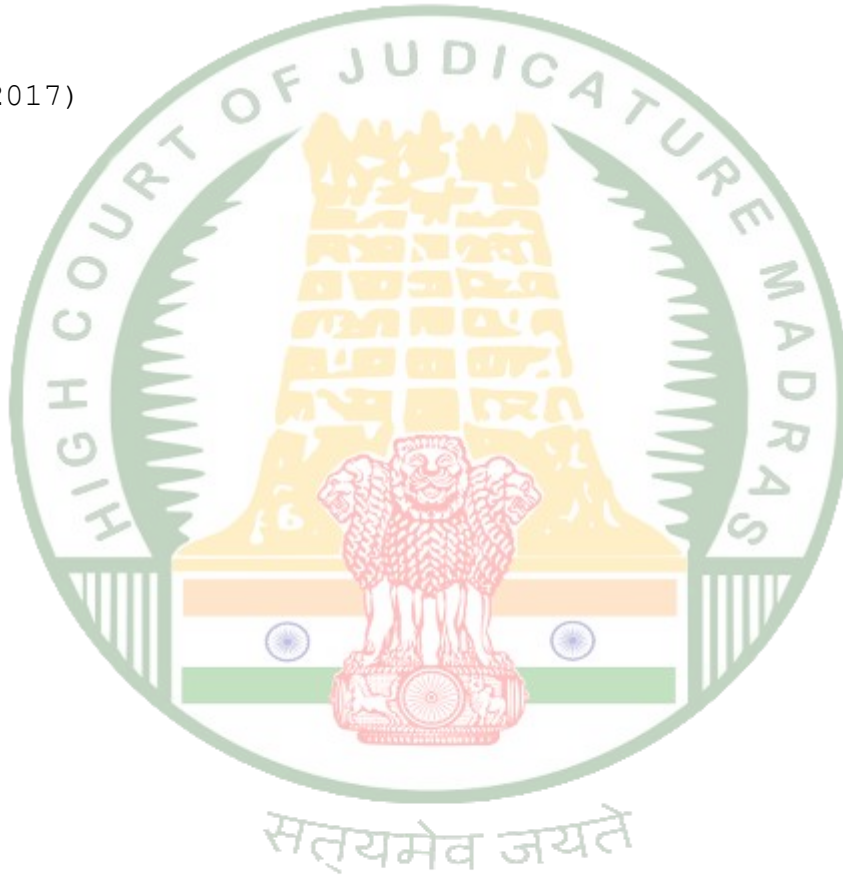
