This Habeas Corpus Petition has been filed under Article 226 of the Constitution of India praying to call for the records relating to the detention order passed in BCDFGISSSV No.257/2017 dated 10.05.2017 by the Detaining Authority against the detenu by name, Ravindran, aged 28 years, S/o.Jambulingam, residing at Periyakuppam (Thazhankuppam), Ennore, Chennai and quash the same.

2. Learned Additional Public Prosecutor has submitted to the effect that the Detention Order in question has already been revoked by virtue of G.O.Rt.No.2952 dated 22.06.2017 and a copy of the same is submitted, wherein, it is clearly stated that the Detention Order in question has been revoked.

4. In fine, this petition is dismissed as infructuous.
