This Habeas Corpus Petition has been filed under Article 226 of the Constitution of India praying to direct the respondents 1 to 3 to trace out and produce the detenue by name, Deenadayalan, aged 33 years, S/o.Narayanamoorthy.

2. It is represented on the side of the respondents 1 to 3 that the detenu has surrendered before the concerned Court in connection with Crime No.509/2011, Triplicane Police Station and subsequently, remanded to custody.

On the basis of the said representation, this Court has directed the respondents 1 to 3 to submit the concerned case diary and perused the same and ultimately found that in connection with Crime No.509/2011, the detenu has surrendered before the concerned Court and subsequently, remanded to custody.

4. Considering the aforesaid factual circumstances, the relief sought in the present petition has become infructuous.

5. In fine, this petition is dismissed as infructuous.
