This Court, at this stage, is not expressing any view on the claim made by the petitioner, as it is for the 1st respondent to consider and decide the same. Thus, this writ petition is disposed of, only with a direction to the 1st respondent to consider the Revision Petition dated 02.03.2017 filed by the petitioner and pass orders on the same on merits and in accordance with law within a period of twelve weeks from the date of receipt of a copy of this order.
