1.The only issue, which arises, in this case, is, as to whether the petitioner ought to be granted notional increment for the period, he did not have the necessary qualification.

2.The petitioner, admittedly, has made representations, in that behalf, dated 28.07.2016 and 14.09.2016.

2.1.These representations, which were received by respondent no.3, i.e., The Registrar General, have already been forwarded to respondent nos.1 and 2. सत्यमेव जयते

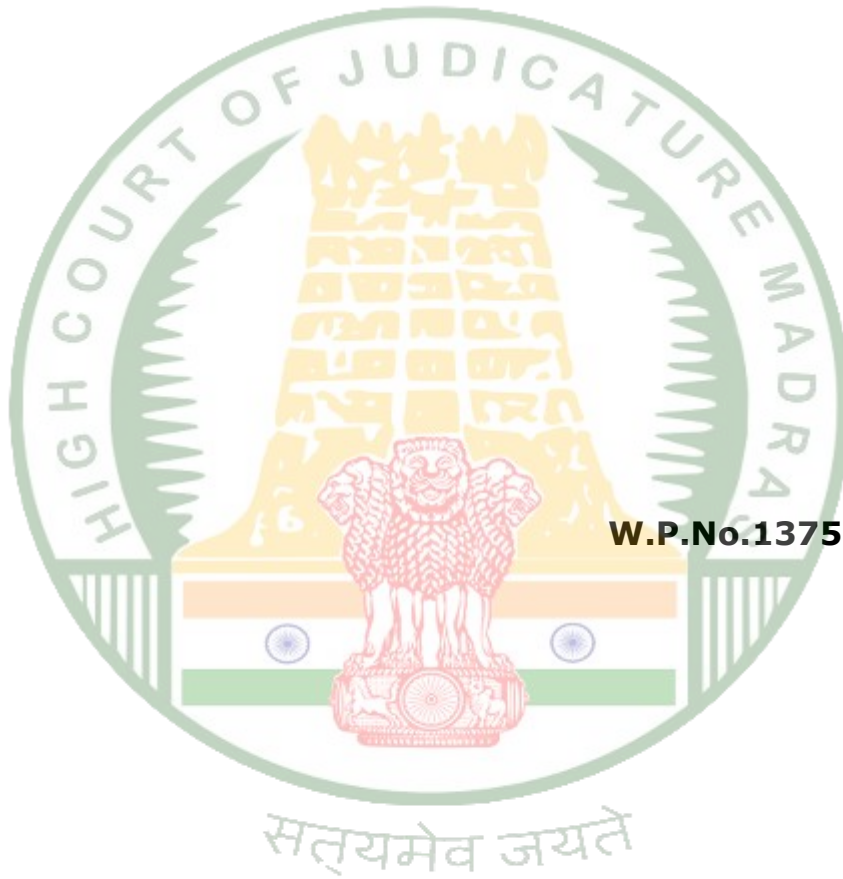
