PETITION FOR ANTICIPATORY BAIL Under Sec. 438 Cr.P.C.

ORDER : The Court Made the following order :-

The petitioner, seeks Anticipatory bail for the alleged offence under Section 294(b), 324, 506(ii) IPC @ 147, 148, 294(b), 324 and 307 IPC in Crime No.1145 of 2017.

2. Heard both sides.

3. Totally there are 5 accused in this case. The case of the prosecution is that while bursting crackers, there occurred a quarrel between the defacto-complainant and the accused persons and at that time, this petitioner along with other accused, attacked the defacto complainant with iron rod.

4. The learned counsel for the petitioner would submit that this is a case in counter and on the date of occurrence, the family members of the defacto complainant attacked the husband of the petitioner and for the same, a complainant has also been filed against them.

5. The learned Government Advocate (CrI. Side) submitted that this is a case in counter and the injured was discharged from the hospital.

6. Having regard to the fact that the injured has already been discharged from the hospital and taking into account that the petitioner is woman and she has no bad antecedent and it is not stated that petitioner's custodial interrogation is necessary, I am inclined to grant anticipatory bail to the petitioner, subject to the following conditions.

7 (i) Petitioner is ordered to be released on bail in the event of her arrest or appearance before the learned Judicial Magistrate No.1, Tiruvannamalai, within a period of fifteen days from the date of receipt of a copy of this order on her executing a bond for a sum of Rs.10,000/- (Rupees ten thousand only) with two sureties each for a like sum to the satisfaction of the said Magistrate.

(ii) the petitioner shall report before the respondent police as and when required for interrogation.
