There shall be an order of interim stay of the execution of the Award dated 8 April 2015 in LAOP Nos. 78 to 80 of 2015, subject to the condition that the petitioner shall deposit the entire compensation amount awarded by the Reference Court along with all statutory benefits, payable to the claimants as per the Award, within a period of twelve weeks from the date of receipt of a copy of this order, failing which, the interim stay granted shall stand vacated automatically without any further reference to this Court.
