Though a larger relief is sought, considering the pendency of the representation of the petitioner dated 05.05.2017, with regard to the relief sought, without going into the merits of the case, the writ petition is disposed of directing the 2nd respondent, namely, the Revenue Divisional Officer, Vellore District - 9, to comply with the direction issued by the 1st respondent, after receipt of the report from the Tahsildar, who will also conduct a due enquiry expeditiously, if not done earlier, and pass orders thereon, after putting on notice all parties concerned, on merits and in accordance with law, within a period of four weeks from the date of receipt of a copy of this order.
