Mr.S.N.Parthasarathi, learned Government Advocate, takes notice for the respondent.

The petitioner has filed the above Writ Petition to issue a writ of mandamus directing the respondents to give permission to him to conduct a Cultural Program (Adalum Padalum) scheduled to be held on 08.09.2017 at "Katteriamman Temple" at No.100, Ex Thalaivar Vattam, Ammaiappan Nagar, Jollarpettai, Pakirithaka, Vellore District 635 853 by considering his representation dated 19.08.2017.

3.It is the case of the petitioner that in spite of the representation being given to the respondent on 19.08.2017 for conducting cultural programme in the Temple on 08.09.2017, the respondent has not passed orders till today.

4.A Division Bench of this Court in W.P.(MD).No.3773 of 2017 by order dated 03.03.2017 in similar circumstances directed the

respondent to consider the representation of the petitioner therein and dispose of the same.

5.Following the order passed by the Division Bench, I direct the respondent to consider the petitioner's representation dated 19.08.2017 and pass orders, on merits and in accordance with law, today itself.

With this observation, the Writ Petition is disposed of. No costs.

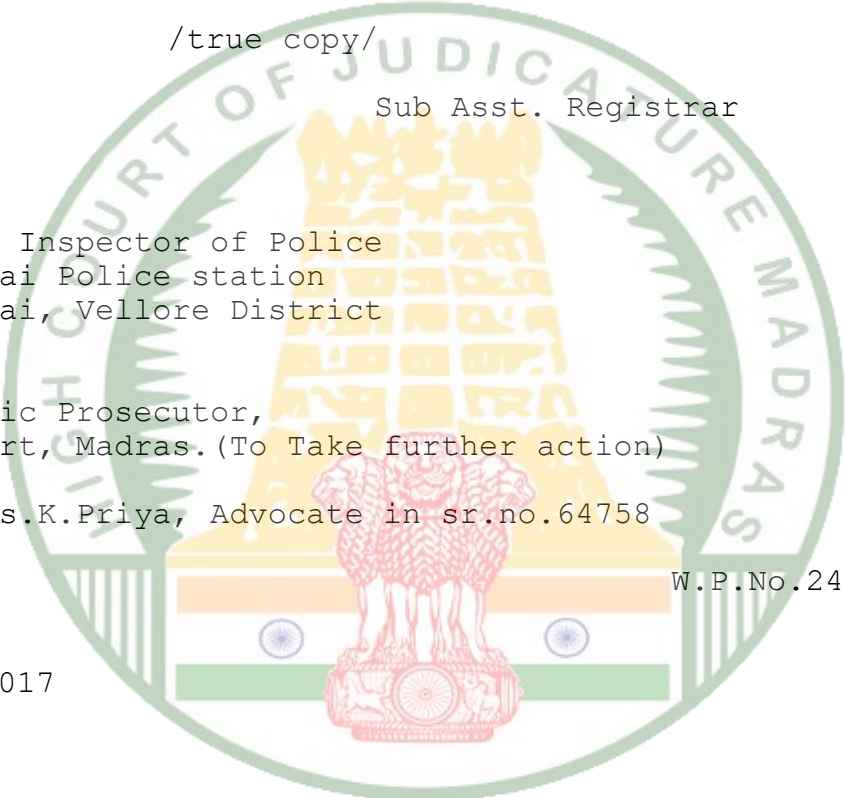
