2. The complainant initiated a prosecution in S.T.C.No.68
of 2013, against the accused for the offence under Section 138
of Negotiable Instrument Act, in which, the learned Judicial
Magistrate, Fast Track Court, Hosur, has acquitted the accused
by judgment on 25.02.2014. Challenging which, the complainant
has preferred the present appeal against the order of acquittal.

3. Notice has been served on the accused and Mr.J.James,
learned counsel has entered appearance on his behalf.

4. Heard the learned counsel for the complainant and the learned counsel for the accused.

5. In view of the judgment of a Full Bench of this Court in S. Ganapathy vs N.
