The learned Government Advocate [Crl. Side] submitted that the petitioner has been regularly complying with the condition imposed by this Court in Crl.O.P.No.24514/2017 dated 17.11.2017. He further submitted that investigation is almost over.

2. Learned counsel for the petitioner submitted that the petitioner is facing life threat as the opposite party also belongs to the village of the petitioner. Therefore, he prays that he may be permitted to sign before some other police station.

3. Considering the submission made by both sides, the condition imposed by this Court in Crl.O.P.No..24514/2017 dated 17.11.2017 is modified to the effect that the petitioner shall report before the Salem Town Police Station daily at 10.30 a.m., for a period of four weeks and thereafter, he shall appear before the respondent police as and when required for interrogation.
