PRAYER: Criminal Appeals filed under Section 372 of the Code of Criminal Procedure, to set aside the order of Acquittal passed against Accused Nos.5 & 6 and Order of Acquittal against Accused Nos.1 to 4 under section 377 of I.P.C. and lesser awarding of punishment against Accused Nos. 1 to 4 & 7 under section 4 of Tamil Nadu Prohibition of Ragging Act, 1997 in S.C.C. No.1 of 2013 dated 25.01.2016 on the file of the Learned

Sessions Judge, Mahalir Neethimandram, (Mahila Court), Coimbatore and allow the appeal by (a) enhancing the conviction of the Accused Nos.1 to 4 and 7 to undergo two years of imprisonment for the offence under section 4 of the Tamil Nadu Prohibition of Ragging Act, 1997 along with a fine of Rs.10,000/- each. (b) convicting the Accused Nos.5 and 6 under section 7 of the Tamil Nadu Prohibition of Ragging Act, 1997 (C) convict the Accused Nos.1 to 4 under sec.377 of I.P.C. And (d) direct the Accused Nos.1 to 7 jointly and severally to pay compensation of Rs.5,00,000/- to the appellant under section 357 of Cr. P.C.

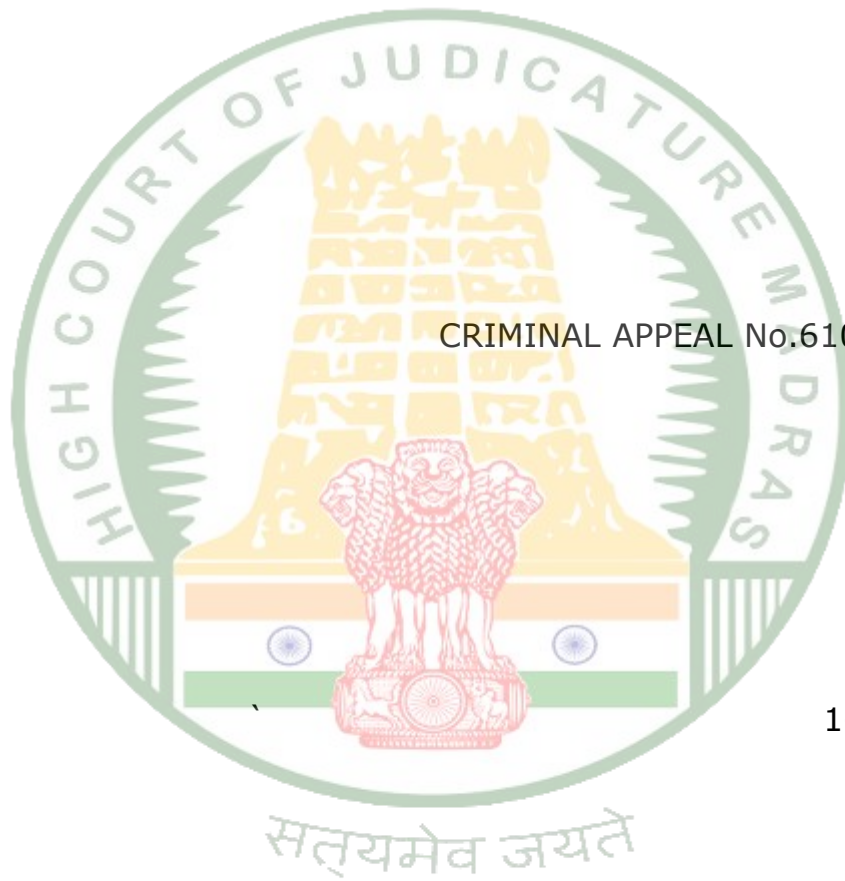
