4.Mr.R.Rajeswaran, learned Special Government Pleader, appearing for the respondents 1 to 5 submitted that the 1st respondent may be directed to consider the petitioner's representation dated 08.09.2017 and pass orders, in accordance with law, after giving notice to the 6th respondent, within a period of eight weeks.

Having regard to the submissions made by the learned counsel on either side, without expressing any opinion with regard to the merits of the case, I direct the 1st respondent to consider the petitioner's representation dated 08.09.2017 and pass orders, in accordance with law, after giving notice to the 6th respondent, within a period of eight weeks from the date of receipt of a copy of this order.

With these observations, the writ petition is disposed of.
