2. Heard both sides.

3. It is submitted by the learned counsel appearing for the petitioner that extension of time is sought for on the ground that the petitioner was suffering from dengue fever and therefore, he could not comply with the conditional order passed by this Court.

Considering the reasons stated in the accompanying affidavit filed in support of this petition and being satisfied with the same, this petition, seeking extension of time to execute the sureties as well as for depositing the amount to the credit of the trial court, is ordered and time is granted by three weeks from the date of receipt of a copy of this order to comply with the same.

5. This Criminal Miscellaneous Petition is ordered accordingly.
