O R D E R

This petition has been filed seeking to quash the proceedings in Crime No.6 of 2016 on the file of first respondent.

2.Pending Criminal Original Petition, the defacto complainant and the petitioners have amicably resolved the dispute among themselves and accordingly, they have entered into a compromise and filed a joint compromise affidavit, dated 14.11.2017 before this Court.

3. Today, the defacto complainant and the petitioners are personally present before this Court and they have been identified by their counsel on record. The counsel for the

parties have submitted the photo copies of the parties in respect of Aadhar Cards viz., Karthick S - Aadhar No.8335 4156 9380, Malarkodi S - Aadhar No.6008 8590 0193, Sirinivasan K - Aadhar No.6619 2891 1512 and Kalaiarasi M - Aadhar No.9644 3231 4895 and after verification of the original cards, the same were also recorded.

4. A Joint compromise affidavit, dated 14.11.2017 has been filed by both the defacto complainant as well as petitioners to the effect that the defacto complainant has no objection, if the present Criminal Original Petition is allowed.

5. In view of the above submissions made on either side and taking into account, the compromise entered into between the parties, the proceedings in Crime No.6 of 2016 on the file of first respondent is hereby quashed.

6. The Joint compromise affidavit, dated 14.11.2017 filed by the defacto complainant/M.Kalaiarasi, is hereby recorded. The Criminal Original Petition is allowed. The Joint Compromise Affidavit, dated 14.11.2017 shall form part of the order.
