Writ Petition filed under Article 226 of the Constitution of India praying for the issuance of a Writ of Certiorarified Mandamus calling for the records of the respondents, especially the first respondent, relating to his proceedings made in letter No.12238/MA1/2011-5, dated 10.10.2011 and the consequential proceedings of the second respondent made in R.O.C.C3/54158/2008, dated 14.10.2011 and quash the same as null and void, illegal and invalid and consequently directing the respondents, especially directing the second respondent/District Collector to grant permission to run 'Christian Education House' established to conduct Bible Classes in the existing structure, comprised in R.S.No.666/2 of Manavalakurichi Village, apart from according sanction to put up of Pucca construction for the same purpose in the same survey number, in the light of identical order passed W.P.No.4151 of 2008 dated 30.04.2008, and the order implementing the same by the second respondent herein.
