Writ Petition filed under Article 226 of Constitution of India, to issue a Writ of Certiorarified Mandamus, calling for the records of the 3rd respondent's proceedings bearing Lr.No.CFC/FC/REV/AAO/HT/D.419/2014, Dated 11.07.2014 in so far as the petitioner is concerned and the consequential impugned demand notice in Lr.No.SE/UEDC/UIDT/DFRC/AO/R/AAO/HT/AS/F.166 CSS/D/17 dated 28.6.2017 issued by the 6th respondent and quash the same as being arbitrary, illegal and without authority of law and contrary to the provisions of the Electricity Act 2003 and consequently direct the respondents to make payment of Rs.22,05,023/- towards the unutilized bank energy as on 31.03.2017 payable to the petitioner along with 1 % interest from the due date to the actual date of payment.

ORDER

The learned counsel appearing for the petitioner seeks permission of this Court to withdraw this writ petition, by a letter dated 14.12.2017. Accordingly, this writ petition is dismissed as withdrawn. No costs. Consequently, connected miscellaneous petitions are closed.
