Needless to say that the 3rd respondent, namely, Tahsildar, Ayyanavaram Taluk is to consider the said request of the petitioner and pass orders on the same on merits and in accordance with law without loss of further time. Accordingly, this writ petition is disposed of without expressing any view on the merits of the claim made by the petitioner only with a direction to the 3rd respondent to consider the application of the petitioner dated 21.12.2016 and pass orders on the same on merits and in accordance with law after giving due opportunity of hearing to the rival claimants, if any. Such exercise shall be done by the 3rd respondent within a period of four weeks from the date of receipt of a copy of this order. No costs.
