This petition is filed for a direction to the Special Court SC & ST Act, (Sessions Court), Villupuram to consider the petitioners' bail petition on the same day of their surrender in connection with Crime No.781 of 2017, since the offences are pertaining to the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities) Act, 1989.

2.In view of the specific bar under Section 18 of the Scheduled Castes and Scheduled Tribes (Prevention of Atrocities)
