2. The only relief sought in this instant petition is to direct the official respondents to conduct a detailed comprehensive enquiry and investigation, in respect of the allegations of tampering of the Court's records in O.S.No.105 of 2003 on the file of the Sub-Court, Tiruppur.

3. All the records have been summoned and placed before the Registrar General, High Court of Judicature at Madras, Chennai.

4. At this stage, we are not inclined to make any observation in respect of the dispute. The interest of Justice will be sub-served, by directing the Registrar General to examine the records, make appropriate enquiry and if necessary, take consequential action against the erring officials, in accordance with law within a period of four months from the date of receipt of a copy of this order.

5. With the aforesaid direction, this writ petition is ordered accordingly. No costs. Connected M.P.No.1 of 2015 is closed.

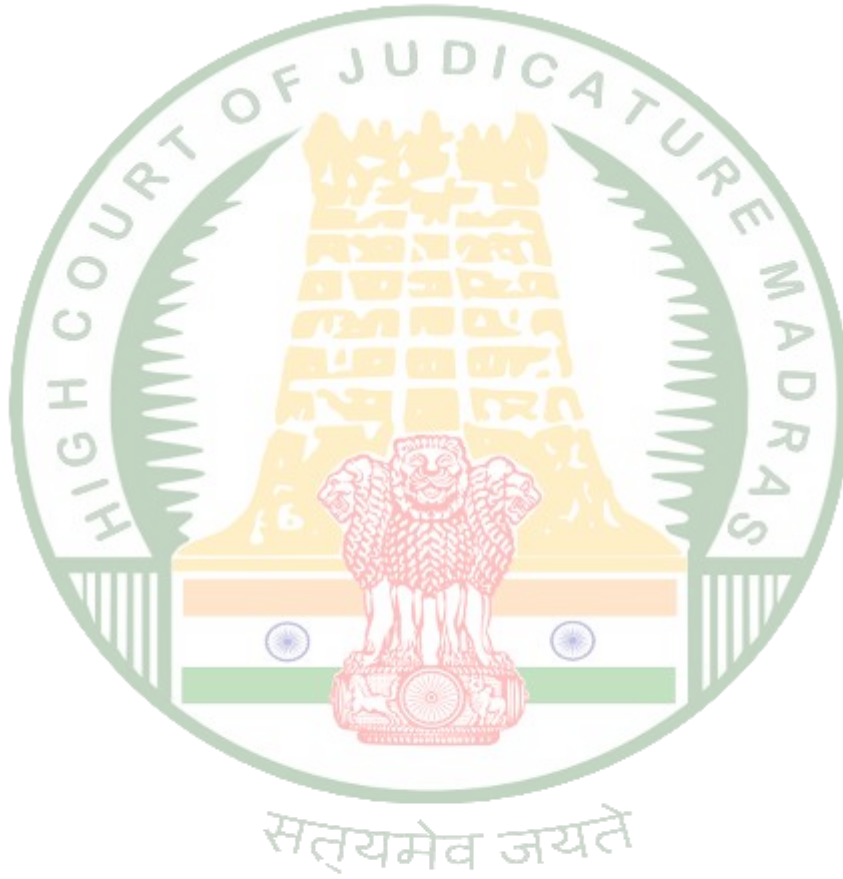
