COMMON ORDER

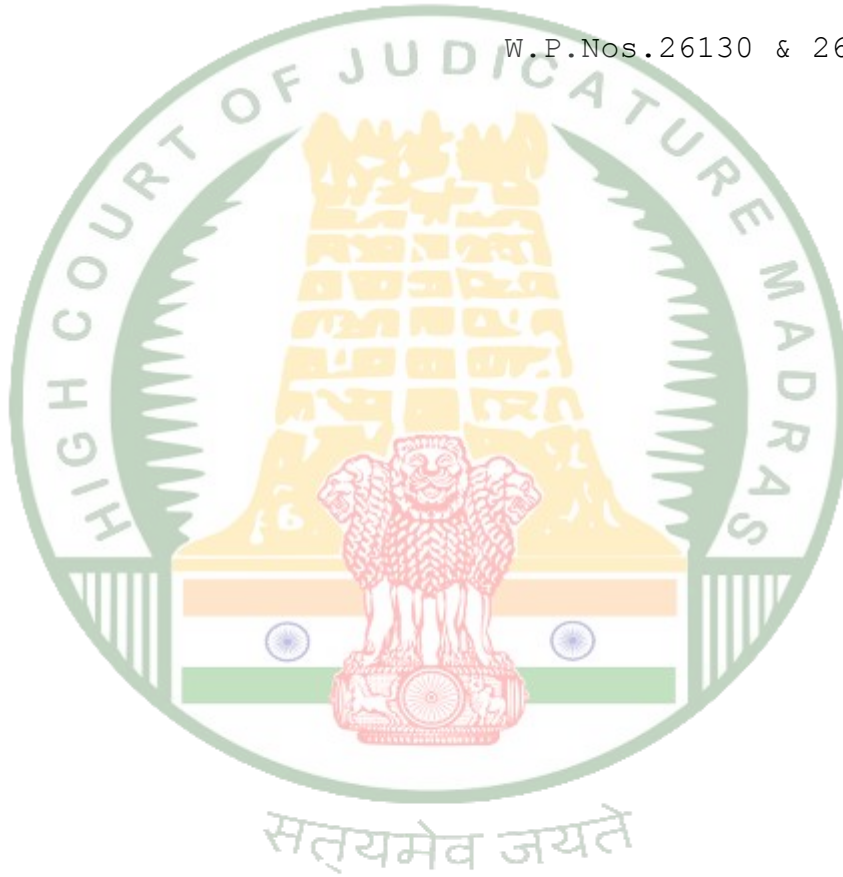
